- 18,400,000 ordinary shares were transferred by Maitland Trustees Limited as trustee of the MGR Trust to Solon (I.O.M) Limited as trustee of the Oxalis Trust.
- Maitland Trustees Limited as trustee of the MGR Trust appointed Danmer Limited, a company registered in the Isle of Man of which Mervyn Greene holds 50% of the ordinary shares, as a potential beneficiary of the MGR Trust.
